Bidders are requested to incorporate the changes/clarifications noted below to the above tender documents in your possession and be governed accordingly.

1. Reason for Extension of the Closing Date

Please be advised that shortly before the closing time on November 21, 2016, the Region became aware of a potential irregularity in the tendering process. As a result, the Region extended the closing date to November 24, 2016 in order to properly investigate the irregularity, which has since been resolved. We apologize for any inconvenience which this may have caused plan takers.

2. Revisions to Addendum No. 8

Addendum No. 8 issued on November 17, 2016 has been revised as follows:
Answer to Question 1 in the Architectural Addendum 05 has been deleted and replaced with the following revised answer:

Q1: Drwg CV-2 refers to Water Chamber OPSD 701.011; this is for a manhole with bench. Details of Water Chambers are in the 1101.01 series of OPSD; which one? Is it a single check ...or a double check valve chamber???

Revised Answer: Water chamber shall be in accordance with OPSD 1101.01 (most current edition and amendments in effect as of date of tender closing) with dimension "a" of 1500. For the purposes of the tender, the provision of a valve and detector check valve shall be included in the Contract Price.

3. Responses to Bidders' Questions

The following are responses to questions submitted by bidders:

Q1 Is this project to start for winter?

A **The Contract Price shall be based on the assumption that the construction will commence in the winter. The Region, however, may postpone the commencement date to April 1, 2017. Bidders are requested to provide the amount of credit that will be applied to the Contract Price if the notice to commence the Work is postponed to April 1, 2017. Please refer to the Bid Form and the Region's Addendum #3 for further information.**

Q2 ...Addendum # 5, Q7 of Arch. add #2 you responded "within the roadway, suitable native" obviously from the drawing 'General Note # 8"...I could understand, although not specified, that it would be in the boulevard part of the roadway....

However, I do not know a Municipality or Region, as in this case York, who would accept 'native' in especially a four lane road....
