Q1 – Please clarify the following item:

As per the tender package: drawing file: "12226-8-10-1026Finch A-E.pdf", it states the Project Address is Finch Yard - BLDG A 1026 Finch Ave W. Please identify if this is one of the location as shown on the tender document. Please state which projects should be allocated.

- 1. 20 Beffort Rd Fire Hall No. 145
- 2. 1009 Sheppard Ave W Fire Hall No. 143
- 3. 1026 Finch Ave W Finch Yard Building B
- 4. 1026 Finch Ave W Finch Yard Building D
- 5. 1300 Sheppard Ave W Toronto Animal Shelter North Shelter
- 6. 4100 Keele St Fire Hall No. 141
- 7. 4330 Dufferin St Emergency Service Headquarters Parking Structure
- 8. 4330 Dufferin St Fire, EMS HQ & EMS Station 53
- 9. 5700 Bathurst St Fire Hall No. 112 & EMS Station 16

A1 – 12226-8-10-1026Finch A-E.pdf was accidently added. It should not be in this tender package. It is not related to any of the 9 project locations in the tender.

Q2 – Please clarify the scope of work for 4330 Dufferin St - Emergency Service Headquarters Parking Structure V.S. 4330 Dufferin St - Fire, EMS HQ & EMS Station 53. Since the drawing file for both project is 4330 Dufferin St - Emergency Service Headquarters Parking Structure and 4330 Dufferin St - Fire, EMS HQ & EMS Station 53 are combined into "122260-TAU-8-229-4330DFRN-2021-7-23-TENDER.pdf", we would like to identify/distinguish/separate the drawing page number / tile for the scope for 4330 Dufferin St - Emergency Service Headquarters Parking Structure V.S. 4330 Dufferin St - Fire, EMS HQ & EMS Station 53.

A2 – 4330 Dufferin St - Emergency Service Headquarters Parking Structure and 4330 Dufferin St - Fire, EMS HQ & EMS Station 53 are both on the same property. The site plan shows the parking structure very clearly. All of the work related to the parking structure is captured on sheets A1201, A1203 and A2000 (staging). The only scope of work for the parking structure is the changes to the two exterior stairs.

Q3 – There is one set of drawings for 1026 Finch Ave W, Finch Yard Building A. It is not part of the listed sites. Should GC include it in the base bid?

A3 – 1026 Finch Ave W, Finch Yard Building A is not part of this tender. Please ignore it.

Q4 – Which set of drawings is for Site 7, 4330 Dufferin St, Emergency Service HQ Parking Structure?

A4 – The parking structure and Head quarter drawings are combined as one set, there's no separate drawing for the parking structure. Drawings A1201, A1203 and A2000 are the drawings in the overall 4330 Dufferin package that capture the scope for the parking structure. It's only 2 stairs with tactile features on the same property.
