
Question 1:

- A) Vision panel glass to be 6mm clear tempered glass as per e2/A608 or 10mm laminated as per e1/A601
- B) Confirm if the glass screens are to have recessed u-channel surround, refer to e2/A600 and e2/A601
- C) The glass screen from the security room in e2/A600 is to be curved similar to the wall
- D) 3m steel plate and edges around glazed screens are by others

Answer 1:

- A) 6mm tempered
- B) Hardwood Flush glazing bead as detailed in sketch below.




- C) Correct, 6mm tempered curved glazing at reception
