#### 2. BIDDERS QUESTIONS (Q) AND REGION'S RESPONSES (A)

#### Question 1:

To quote the curved glass for the security glass within the portion our supplier has advised that they require the attached information if possible.

#### Answer 1:

The glass at the new Security Room is slightly curve and will be custom. The radius provided now will likely be different that what is built on site. The curve glass will need to be templated before fabrication.

# **Question 2:**

Please confirm if this project is regular hour, and what is the estimated start / end time.

#### Answer 2:

This is an afterhours project. Refer to bid documents: Supplementary Conditions, SC 1 Working Hours, and SC3 Operation Constraints

# **Question 3:**

Please confirm the bonding is only for GCs, but not subcontractors.

### Answer 3:

General Contractor only.

### **Question 4:**

The drawings indicate there is a Base Building BAS controls contractor, but I don't find them listed anywhere. Do you know who the contractor is?

### Answer 4:

There is no pre-qualified BAS Controls Contractor. # Question 5:

The drawing shows 5 pipes to be relocated around the new FCU but doesn't show the sizes. Is there any more information available on their size and material types.

# Answer 5:

The 4 existing steel pipes are main chilled & heating water supply /return pipes and are assumed to be 65mm diameter in size. Contractor to allow for welding of all pipes for sizes 65mm & larger as per mechanical specification section 23 05 10. The 5<sup>th</sup> pipe is a condensate pipe serving the existing fan coil units on the 2<sup>nd</sup> floor which is assumed to be 50mm in diameter.

# **Question 6:**

Please clarify if wood door #05C is to be Type B with glasslite per 2/A608 or Type C without glasslite per 3/A608?

### Answer 6:

Disregard any reference to a Door 05C - there is no door 05C. Detail 2/A608 pertains to Door 05B and detail 3/A608 pertains to Door 01.

# Question 7:

Please clarify if interior finish of cabinets in area 1-04B, 1-05 & 1-09 are to be wood veneer as well, same as exterior finish?

### Answer 7:

All interior millwork finishes to be same wood veneer as exposed finish.

### **Question 8:**

Is steel plate required around glass on 2/A601?

#### Answer 8:

Yes, steek plate is require round glass detail 2/A601.

#### **Question 9:**

Please advise if this job have union requirements.

### Answer 9:

No.

# **Question 10:**

Please advise the estimated start and finish date for the project.

#### Answer 10:

The estimated start will be April 2024. The expected duration – please refer to the bid document: Amendments to CCDC 2 Stipulated Price Contract 2008, Agreement Between Owner and Contractor, Article A-1 The Work.

### Question 11:

Please clarify if specs for WV-1 at millwork is solid birch veneer per Section 064000 Item #2.1.5 & 2.1.6 or composition board veneer per Section 064000 Item #2.2.2.3 & 2.2.2.5?

#### Answer 11:

Wood veneer on this project is birch throughout.

### Question 12:

Please advise if the separated prices on Table A of the Schedule of Prices are for information purposes only and will not be used to delete scope from the project.
