


Figure 1: Site Entrance

- Respondents shall meet at the specified time, at the Yonge Street Entrance, located on the west side of Yonge Street and north of Mulock Drive as indicated in Figure 1 of the RFP and this addendum.

Personnel not wearing the above equipment, may not be permitted access to the work site.
