All Bidders are advised by this addendum to incorporate the following changes/or clarifications to the above noted Document.

**1. Intent:**

- a. This Addendum is issued during Bidding and shall form part of Bidding and Contract Documents for above Project.
- b. To maintain traceability of questions, the numbering remains consistent with the sequence assigned in previous addendum(s). For clarity and brevity, any question numbers missing from this addendum have been addressed in prior addendum(s) and are omitted.

**2. Extension of Closing Time:**

Closing Time has been extended on the Bidding System from 2:00:00 p.m. local time, on Tuesday, December 17, 2024, to 2:00:00 p.m. local time, on Wednesday, December 18, 2024.

**3. Bid Form Update to Schedule of Pricing**

The Summary Table in the Schedule of Prices has been updated to include the lump sum price for Provisional Work. The updated Summary Table will include the following prices that will add up to the Subtotal Contract Amount:

- Base Scope of Work Lump Sum
- Provisional Work Lump Sum
- Cash Allowances in the total amount of \$540,000.00

**4. Revision to Alternative Price Submission**

Bidders will be allowed to submit their prices for Alternative Price - Separate Prices and Unit Prices - within 48 hours after the Closing Time – on or before 2:00:00 p.m. local time Friday, December 20, 2024. (Alternative Prices Submission Deadline).

Bidders shall use the Bid Form to complete and submit the Alternative Prices to the Purchasing Representative by emailing the completed Bid Form to [50082@yrp.ca](mailto:50082@yrp.ca).

The spaces for entering prices in the Pricing Tables for the Alternative Prices - Separate Prices and Unit Prices) are no longer mandatory – this means that if Bidders do not enter prices for those items as part of their electronic bid submission, the bids will still be accepted. **For clarity, Bidders are required to submit lump sum prices for the Base Scope of Work and Provisional Work as part of the electronic bid submission.**

Failure to submit fully completed Alternative Prices prior to the Alternative Prices Submission Deadline may, in the Board's sole discretion, result in disqualification of the bid.

This addendum shall remain attached to and form part of the Contract Document. Your co-operation in making the above noted changes is much appreciated.
