Question 1:

Are there any current, or potential construction camera requirements for this project, or would the selected firm seek after such services at their discretion?

Answer 1:

The successful bidder is required to obtain the wrap-up liability and builder's risk insurance for this project. Bidders should ensure that construction cameras are

compliant with all risk mitigation requirements and documentation standards set by insurers.

Question 2:

The Bids & Tenders posting indicates in the advertisement writeup that this project is by invite only for GCs, but it appears as per the tender docs that the project is an OPEN tender. Can you please confirm if this is an open tender, or was there a previous prequalification process completed for the General, Mechanical, Electrical or other subcontractors as well? If this is an invite only can JR Certus Construction be considered invited?
