**BAS**: On-site Programmable Logic Controller's should have the ability to integrate with our Schneider Electric StruxureWare Building Automation System (BAS) as an expansion site to the existing system.

**Fire Alarm/Sprinkler System**: Mircom. Must be ULC Compatible and must communicate with monitoring company: Cobra.

**Communications**: City of Vaughan will be providing all communication services for communication, security, access control, CCTV and BAS.

## Question 3:

The Cash allowance noted DSS removal, Please confirm whether it is for all known asbestos removal or for unknown asbestos above what have been identified?

## Answer 3:

Cash Allowance noted for DSS removal is for all known asbestos removal as identified.

# Question 4:

Is the roofing scope of work for the new RTU included in the cash allowance?

## Question 6:

Please can you confirm the requirements of the performance bond. In the key details on T24-388, the performance bond amount required is 100%; whereas, in SC44 section, we understand that the performance bond should be 50%. Please advise.

#### Answer 6:

The Performance Bond required is 100%.
