#### Question 1:

We have not seen room finish plan or Room finish schedule. Please provide it.

#### Answer 1:

The Consultant has shown the finishes in all floor plans, elevations, sections and interior elevations by means of a material tag that links the specific finish to the Material Schedule found on Sheet A004. This is done with the intent of being more accurate on the finish to a specific wall, floor, room, or any other architectural element, given that inside one room we have multiple type of finishes, paint colors, etc. we do not feel comfortable providing a "rooms finish schedule" as it could lead to inaccuracies. Please review overall package and how it relates to Material Schedule Sheet A004.

#### Question 2:

The site video link of Addendum 01 does not work and / or the video cannot be accessed by trades, City please arrange a site walk through for the interested bidding general contractors, demolition, asbestos abatement, concrete cutting, floor self-leveling, structural reinforcing, mechanical, electrical and restoration trades or providing valid video link and pre-construction survey report w/ photos of existing conditions for bidding purpose

# Answer 2:

All video links in Addendum 01 have been tested and able to open properly. The issue appears to be on the user side.

#### Question 3:

Both fiberglass window types are tagged as W01, please can you clarify if there should be a difference?

#### Answer 3:

The W01 only represents they are fiberglass windows, there is no other difference other then the width. The window with a width of 914mm is referencing drawing 1/A401 – North Elevation, the big window at the kitchen & Dayroom space and Fitness Room on the second floor is composed of 4 x 914mm windows.

#### Question 4:

Epoxy flooring question: Could you please approve Sikafloor Morritex System as a proposed product. Also, please provide the required thickness for this epoxy application. The proposed system has a range of 1/8 to 1/4 like the Stonclad system mentioned in specs.

## Answer 4:

ATA does not recommend switching to "Sikafloor Morritex System".

## Question 5:

Regarding pricing the exterior brick repairs, please provide spec for the brick.

#### Answer 5:

<u>Type:</u> Brampton Brick – Legacy Series - Old Chicago <u>Size:</u> Premier Plus 257 x 79 x 90 mm (10 1/8 x 3 1/8 x 3 1/2") Bricks per square foot 3.9 Bricks per square metre 42

#### Question 6:

Please advise if steel stud framing is required to be provided at P02? The wall type calls for hat channel (by ACM panel installer), however detail 4/A704 shows 2-1/2 inches steel stud framing.

If framing is required to be included, please can you confirm the locations as the drawings seem to vary between these details.

#### Answer 6:

P02 and P02A (Insulated) both call for a hat channel (by ACM Panel Installer). However, there are walls that vary in CMU block thickness, see Wall Section 3/A701, from bottom of wall to top of wall, there are three (3) different Existing CMU block thicknesses, in order to align the ACM panels, additional subframing will be required in some areas (by Contractor). Those areas are hatched in red on elevation sheets A401 and A402.

#### Question 7:

Please confirm that Supply & Install Trailer is by City of Vaughan.

#### Answer 7:

The City is supplying the trailer, installation is to be completed by the contractor. Refer to architectural drawing A006 and Specifications for more details.

#### Question 8:

Please clarify the following queries below:

- 1. Please provide the detailed room finish schedule for all rooms.
- 2. Please confirm the base finish for entry area to Watch office 102 & Entry Vestibule VS1A, Watch Office 102, Bunker Gear 104, Dirty Janitorial 106A. Extractor / Hose Room 106, Truck Storage 107, & Electrical Room 116
- 3. Please confirm the top landing floor finishes of staircases ST1A & ST1B
- 4. Please confirm height of wall tiles in locker room 111 is up to False ceiling height (2.364m)?
