Please refer to Addendum #1, Answer #1 and Section 3.7 of the RFQ - Procurement Process Non-binding. As there is no Contract A, there is no irrevocable period.

Per updated timetable in Addendum #3, the City's anticipated date of award/Execution of Agreement is June 13, 2025.

Question 8:

We are not able to get a quotation for decommissioning and removing of the existing exterior gas pipeline and gas meter for gas supply company during tender period. Application is to be submitted by City to the gas supplier. Please include decommissioning and removing of the existing exterior gas pipeline and gas meter in Cash Allowance.

Answer 8:

An Enbridge contractor will handle the natural gas service cut-off and relay of the station pad. This work will be coordinated between the City, Enbridge, and the selected proponent during construction. All related costs will be covered directly by the City. The Enbridge contractor will manage excavation, installation, energization, and site restoration.
