There are two site locations. Are we meeting 1st in Jack Darling Memorial Park located at 1180 Lakeshore Rd. W, Mississauga Please confirm.

Question 5:

Please clarify which Park is to be visited first for the site meeting?

Question 6:

Please refer to soil report for HURON PARK COMFORT STATION, prepared by Forward Engineering dated September 18, 2025. Under side of footings has been given 114.20 and it's shown on structural drawing foundation plan on S1-01 as well.

However, report says that per Option 1: existing fill to be removed and raised with suitable material prior to placing of slab on grade or Option 2: structural slab which is not reflected on structural drawing.

Please advise do we require to remove existing fill and replaced with suitable fill or will it be designed as a structural slab? Also, S1-01, under design general notes (SITE PREPARATION NOTES FOR SLAB-ON-GRADE) (WITHIN BUILDING ENVELOPE), note#5 refers to granular B to raise the grade within the building but Geotech report says suitable material can be used to raise the grade. Please confirm if we're going with Option 1 and if yes, what material to use to raise the grade.

Answer 6:

Conventional slab on grade is appropriate, and the material used shall be in conformance to the site preparation notes for slab on grade detailed in the structural drawings.

The existing fill is not suitable due to organic content. Any suitable fill can be used if it is free of organics and any other deleterious materials with natural moisture content, which is within 2 percent of the optimum moisture content and no pieces larger than 150 mm in size. The fill shall be placed in shallow lifts i.e., ±200 mm thick and thoroughly compacted to 98 % SPMDD.

Question 7:

We assume clean fill for the disposal purpose without having soil chemical analysis. Please confirm. If the material is to be imported, chemical analysis is required.?

Answer 7:

For the Chemical analysis, if the material is to be imported, chemical analysis is required. For fill disposal, a Chemical Analysis of the site was completed and report included in

the Project Specifications under Section 00 31 00 Existing Conditions of Appendix I (Huron Park Comfort Station Specifications).

Question 8:

Please refer to Appendix A- STATEMENT OF WORK. Huron Park, project timelines is given for the site services. Please advise start completion date for new comfort station building for Huron Park.

Please refer to Appendix A- STATEMENT OF WORK. 1- JACK DARLING MEMORIAL PARK. West comfort station site will be available to start soon as washroom facility closed for winter period. Please advise completion date for the West comfort station building.

Answer 8:

Start and substantial completion dates for the full project are as per subsection 6.0 Project Schedule in document Appendix C – Statement of Work.

Question 9:

We would like to request a two-week extension to the closing date, as this project involves three separate locations and a complex scope that requires coordination among multiple trades and subtrades. Providing additional time would allow for a more thorough review and ensure accurate and competitive pricing.

Answer 9:

Closing Date of November 17th remained unchanged.
