- 1. All work performed under this RFP-SSR ORE20251180 that is covered by the Provincial Collective Agreement between the Carpenters' Employer Bargaining Agency and the Carpenters' District Council of Ontario, United Brotherhood of Carpenters and Joiners of America, as amended, (the "Carpenters' Provincial Agreement") shall only be contracted or subcontracted to an employer bound by the Carpenters' Provincial Agreement. This notice supersedes the General Labour Conditions (insert relevant contract provision). General Contractors and their Subcontractors not bound by the Carpenters' Provincial Agreement are ineligible to perform work covered by the Carpenters' Provincial Agreement.
- 2. As a result, proof of union affiliation to the Carpenters' Provincial Agreement has been added to the Evaluation Criteria as a mandatory pass/fail requirement.

Attached to this addendum is a copy of revised page # 11 of posted RFP-SSR outlining the revised Evaluation Criteria.
